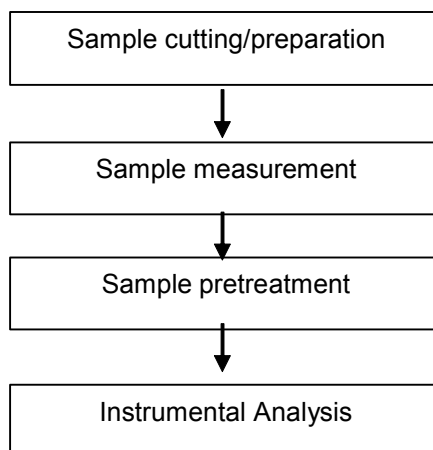

SVHC Testing Flow Chart



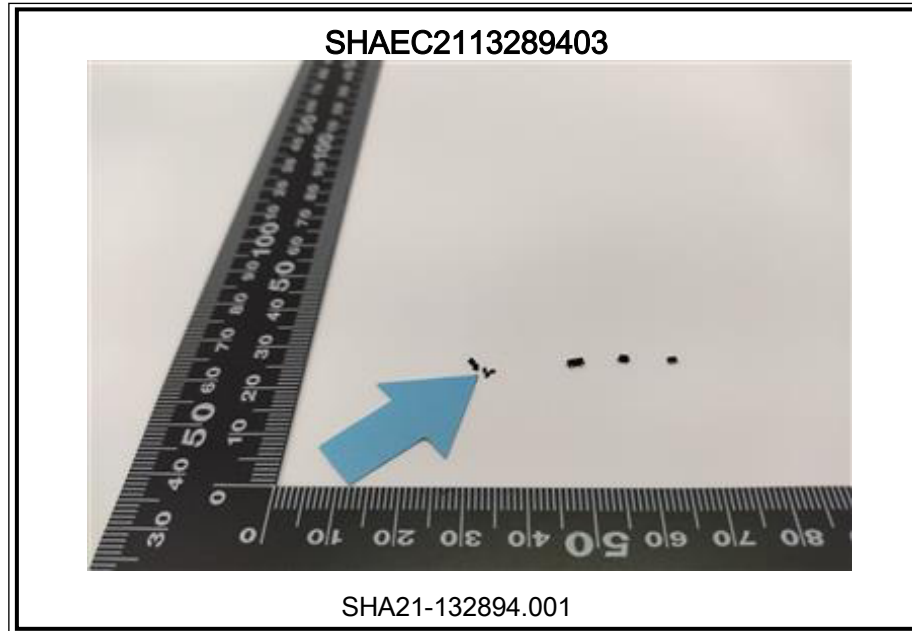
